## Drivers Contract, Liability & Release

### DRIVERS CONTRACT:

Drivers must fulfill the following requirements to be eligible to drive on any CCA related event:

- Must be at least 25 years of age
- Must have a current Driver's license
- Must have valid registration and car insurance
- Drivers Liability and release form
- Provide copies of Driver's License, Proof of Insurance and Vehicle Registration to the office prior to event

I agree with my signature below to all of the following statements:

- I will ensure all passengers in my vehicle are wearing seatbelts at all times
- I will ensure only passengers over the age of thirteen will be allowed to sit in seats that have dash-mounted airbags
- I will provide and maintain a Christ-honoring environment in my vehicle; i.e. Music, videos, conversations, etc.
- I will obey all California road signs and laws at all times
- I will stay on the predetermined course and will not make any (non-emergency) stops without obtaining consent from the activity coordinator
- I will not allow anyone under the age of 25 to drive my vehicle while participating in CCA Events
- I will carry a parental permission slip for each minor under my direct care
- I understand the CCA written Policy and Procedures for Transportation

### LIABILITY AND RELEASE:

I agree to hold harmless Calvary Chapel San Diego, its preschool, elementary school, junior and senior high schools commonly known as Calvary Christian Academy, from any liability which may be caused by others or by myself while transporting students on field trips that are sponsored by the schools.

I acknowledge by my signature below that I carry the required amount of automobile insurance as mandated by the State of California. I acknowledge that all the children that will be riding in my vehicle will at all times wear their seat belts, be placed in car seats (if weight and age deem necessary), and be placed in seats away from dash-mounted airbags, unless over the age of thirteen. I acknowledge that my vehicle is in safe operating condition. I acknowledge that I will not use my cell phone while driving unless I have a hands free device as required by California State Law.
